## PRIVACY POLICY

Privacy Statement: The 28<sup>th</sup> Street Metro Cruise is committed to protecting your privacy. Only authorized employees or representatives of the 28<sup>th</sup> Street Metro Cruise use any information collected from individual users of the website.
